RE: Wave Study

Jason reported that the City Council accepted the Wave Study, and his company as project manager. He will use ATM Consulting Company. Design time will take approximately two months, with 30 days to bid project. Construction should be underway within three to four months.

Chuck Fortin reported that transient traffic is at 70% since July 2014; slip rental occupancy is holding, and fuel sales are going up. He is looking into the possibility of hosting a fishing tournament.
