Michelle Moore with K2 approached and explained the 10% cash match for the grant. She stated July 17, 2020 is the due date for the application.

It was noted that the Funds needed will come out of Road and Bridge fund.

Carly Tabor approached regarding the surveys that were sent out and what has been received by the public.

Elmer Boyd approached regarding the culverts being replaced on his property.

Diane Frederick approached regarding the flooding issues in her area.


Tessa Lewis approached inquiring if the driveways will be fixed as well.






